Complete wiring new construction \$55.00 per unit for 1st 12 units, \$30 per unit thereafter

Additions, remodeling & rewiring \$0 - \$50,000 = 2.5% of value (\$40.00 min fee)

\$50,001 & over = \$1,250.00 for 1st \$50,000 + .0075 of bal.

NOTE: Plan Check Fee required for job cost of \$50,001 and over = .0015 of job cost

Non Residential Fees:

Permit based on job cost: \$0 - \$50,000 2.5% of value (\$40.00 minimum fee)

\$50,001 & over \$1,250.00 for first \$50,000 + .0075 of remaining balance

NOTE: Plan Check Fee required for job cost of \$50,001 and over = .0015 of job cost

MISCELLANEOUS FEES **State Surcharge = \$1.00 when based on fixed amount or .0005 of job cost when fee is based on valuation**
